#CoastalRecovery **Deliverables**

Development and implementation of Local Nature Recovery Strategy Working together to restore and expand habitats, protect, and increase wildlife, combat climate change, and benefit our communities. DCF members are key to the development and delivery of the Local Nature Recovery Strategy in coastal areas.

Enhance existing and create new natural habitats Recent examples include the UK's first super nature reserve in Purbeck, Stour Valley Park and Wild Woodbury in Bere Regis. Identify opportunities to link these areas and create natural 'buffers', and explore the possibility of creating a National Marine Park in Dorset.

Water Quality Improving water quality for the benefit of the environment, wildlife and communities, not only in the sea, but also further up into catchment areas that impact the coast. Greater benefits can be achieved by empowering local communities and working in partnership with water companies, farmers and other key stakeholders. Major structural solutions are long term, therefore open discussion and regularly sharing accessible information on issues, challenges and potential solutions are vital to take everyone on this journey.

Promote sustainable coastal environments and habitats Champion the natural environment, ensuring that people and wildlife on the Dorset Coast benefit from members' projects, activities, and

sustainable fishing and regenerative tarming Working towards a balance between sustainable fisheries and farming with land and sea environments that protect wildlife as well as supporting food production, resilience and links to local communities. Continue to develop local solutions that generate multiple benefits, such as The Poole Clam and Cockle Fishery Partnership Project.

Connecting people to nature Continue to inspire people and communities to learn about, value and act for wildlife. Deliver a range of activities that are accessible for people from all backgrounds and abilities. Importantly, involve young people to learn about their coast, wildlife and employment opportunities that are available in the environment sector, creating 'inspirational leaders' for the future.

<u>Youth engagement</u> Expanding opportunities for education, citizen science and volunteering ...encouraging young people to understand and value wildlife, historic sites, coastal economies, and our changing coast.

<u>Infrastructure connection</u> Linking coastal paths and wayfinding with wider rights of way networks in towns and villages.

Connecting to Seas and Nature A focus on 'Ocean Literacy' – raising awareness on conservation and sustainable use of our global ocean; and 'Local Nature Recovery Strategy' aiming for wider range of people involved in nature recovery.

<u>Greening the grey</u> Increasing green spaces in urban areas, benefitting communities and environments e.g., pollinator planting, green roofs, living walls, tree planting and green corridors.
